2012 Fall Hill Visit

Report to the Alabama SHRM State Council, by Juanita Phillips, SPHR

Our Fall 2012 Hill Visit was a great success. The group was an excellent, cooperative and participatory group. Our twelve attendees included some first-time attendees and represented seven chapters throughout the state. The attendees were as follows:

Attendees are assigned to follow up with thankyou notes to each office, reiterating our topics thereby and offering ourselves as a resource going forward.

An attendee has been assigned to provide feedback on each office visit through SHRM's bit.ly system.

The topics we discussed on the Hill were:

- The need for a bi-partisan solution to prevent sequestration from taking place in January
- As the writing of an agreement to accomplish the above takes place, don't do away with the tax-free status of current employee benefits

- In particular, protect the tax status of education assistance and healthcare premiums
- We asked for more Alabama co-sponsors for H.R. 4137, the Employee Educational Assistance Act of 2012

Some important take-aways for us from my perspective are:

- Our attendees did an outstanding job of making our visit more of a conversation with the members and staffers.
- It is a great help to stay within walking distance of the hill, eliminating the issues of getting the whole group through the Metro system on the day of the visit.
- 1.5 hours for the briefing meeting worked out well.
- We were once again able to arrange free meeting space for our briefing meeting, but should remain aware that we may not always be able to do that.

Having an attendee from each district in our group is becoming necessary. In some cases this will require an additional scholarship from the council for chapters that cannot afford it.

Congressional offices are beginning to disallow our large numbers.

I would like to document once again in this report my ongoing recommendation that chapters make the chapter legislative position a two-year position and that the incoming person attend the fall hill visit before they begin their term in January.

My thanks to the State Council for giving me the opportunity to work in the legislative arena and to attend the hill visits.
